

#### When can you Give?

#### **Giving during your lifetime**

- > For those who wish to make large donations or want to grow their donations over time, a Charitable Trust structure may be the preferred solution. A Charitable Trust may have a limited lifespan or exist
  - in perpetuity both of these options can provide longterm support for the causes close to your heart.
- You may also choose to make regular donations directly to charities of your choice.

#### **Giving after your lifetime**

Giving after your lifetime leaves you with a small window of opportunity to conduct your philanthropy. This may not be the best means of achieving your goals, especially if your vision is to build a sustainable charitable structure or effect large-scale change. You may choose to leave gifts to charities in your Will. This could be in the form of:

- → A bequest/legacy of a fixed sum of money;
- → By creating a testamentary Charitable Trust, you can ensure that your funds are distributed as you intend.

You can appoint the beneficiaries to your charitable intentions by naming them in your Will or you could provide guidance to a trusted adviser who will see to the application of funds in perpetuity. When preparing your Will, Greenthos Capital can provide guidance to make sure you have provided for the individuals you choose, or have an obligation to provide for, while ensuring your legacy can still fulfil your philanthropic goals.
